

TOWN OF JEFFERSON
BOARD OF SELECTMEN
May 26, 2015

The regular meeting of the Board of Selectmen for the Town of Jefferson was held at the Selectmen Office Tuesday May 26, 2015 at 7:00 pm.

PRESENT: Norman Brown, Chairman; and Kevin Meehan members comprising a quorum of the Board.

OTHERS PRESENT: Linda Cushman, Assistant to Selectmen;

Norman Brown opened the regular meeting at 7:05 pm. The Board reviewed and approved the bills for payment next week. The Highway and Transfer Station report was reviewed. The warrants were signed. Terri Larcomb was in to pickup signed warrants and sign checks.

Kevin Meehan made a motion to accept the minutes of the May 18, 2015 Selectmen Meeting as written. Norman seconded the motion. Motion carries.

The Selectmen approved a donation of \$50 to the St. Johns Methodist Church in memory of Carolyn Conway. Mrs. Conway's husband Ray was a Selectmen for many years.

Linda Cushman reported that she had contacted Beattie Enterprise, and they are planning to start the bridge job the end of June. Mr. Beattie said that he would notify the Town in advance so notices could be posted.

Chad Poland of Michie Corp had called asking if the Town would be willing to pay for the concrete castings now as they were manufactured back in December thinking the work was going to be done then. Norman asked if anything had been paid. Yes \$5000 had been paid. Norman said that he would not have an issue in paying half of the invoice now and the balance when it is delivered. Kevin agreed.

Regarding the notice of limits for the James Lewis building, the Town has to file this. The Registry of Deeds would not do the recording without having payment in advance. Once the recording is done a copy will be sent with the building permit to Mr. Lewis.

Linda asked the Selectmen if they wanted to start looking at getting the roof extension at the Transfer Station done. The roof on the office/recycling building as it is now dumps rain and snow on to the walk between the building and containers making it unsafe. It was suggested to check with Mark Dubois to see if they could do the work. If not to contact some of the local contractors to get a price.

As for the replacing of the office door Linda was told to check with Mark to see if they also could do it. The door can be ordered from Perras Lumber. Norman suggested to have someone check the casing to see if a door with casing needs to be ordered or if just the door needs to be replaced.

Linda asked the Selectmen how they would like to schedule the hours for the Transfer Station for July 4th. The 4th is Saturday, which is a normal day of operation. It was decided Friday the 3rd that the Transfer Station would be opened from 1 to 6 pm and that Monday the 6th the hours would be extended to 8 am to 5 pm.

The next meeting will be June 1, 2015, at 7:00 pm.

Kevin made a motion to adjourn the meeting. Norm seconded the motion. The motion carries.

Being no further business the meeting adjourned at 7:25 pm.
