

TOWN OF JEFFERSON
BOARD OF SELECTMEN

July 27, 2015

The regular meeting of the Board of Selectmen for the Town of Jefferson was held at the Selectmen Office Monday July 27, 2015 at 6:30 pm.

PRESENT: Norman Brown, Chairman; Kevin Meehan and Tom Brady, members comprising a quorum of the Board.

OTHERS PRESENT: Linda Cushman, Assistant to Selectmen; Crystal Chase, Play & Learn Ctr.

Norman Brown opened the regular meeting at 6:35 pm. The Board reviewed and approved the bills for payment next week. The Highway and Transfer Station report was reviewed. The warrants were signed. Terri Larcomb will be in later to pickup signed warrants and sign checks.

Tom Brady made a motion to approve the minutes of the July 20, 2015 Selectmen meetings as presented. Kevin Meehan seconded the motion. Motion carries.

Amy Graham, Director the the Lancaster Play & Learn Center has sent an email withdrawing their proposal for use of the Couture Field. The Center does serve some Jefferson children and they did have the necessary insurance.

Linda Cushman reported that she had spoken to Barry Normandeau regarding the installation of the stone at the Ingerson private cemetery located on the land of Jerome Zajic. Mr. Normandeau said that it would take about 4 hours to do the work and pour the foundation, and once the stone is ordered it would take about 6 to 7 weeks for delivery. It would take about 2 hours to set the stone. If the foundations is done once the order is place it will have time enough to setup. Mr. Normandeau had sent a descriptive drawing of the stone.

Norman said that he would draft a permit using the information provided and have it ready for the Boards review next week.

Mark Dubois will be looking into the option of purchasing gravel verse crushing our own. There was a question as to the time, labor and quality of what was crushed in 2013. The size seems larger than what was speced. Kevin said that if the material we have at the pit could be used as a base, then purchase a product that has some fines for a top cost. Mark was going to check with A&B to see what their cost to crush would be. Norman asked if we were to purchase gravel was there a place at the garage to store it. Tom said that he would like to know how much gravel is left at the pit. In 2013, 3300 yards was crushed for \$14,990. Would it be more cost effective to purchase yearly what is estimated as being needed for the year.

The tree removal at the bridge site on the Ingerson Road has been completed. Linda said that she had word that Eversource is in hopes of moving the wires next week. She has let Clayton Christie and Chad Poland know.

There has been no word from the Whitefield Selectmen. Norman said that there has been nothing done to the Airport Road, either

The next meeting will be August 3, 2015, at 6:30 pm.

Kevin made a motion to adjourn the meeting. Tom seconded the motion. The motion carries.

Being no further business the meeting adjourned at 7:00 pm.
