

Town of Jefferson
Select Board Meeting
September 11, 2023
Jefferson Community Center

The meeting was called to order at 7:00 p.m. by Selectman Terri Larcomb, Selectman Kevin Meehan, Select Board Chair Norman Brown (Zoom), Mike Kenison, Kyle Cormier, and Amanda Simino were also present.

The pledge of allegiance was recited.

Mike Kenison: Mike had two quotes for a new grader and for a trailer. The grader is top priority. Funding would be coming mostly from Hwy. Dept. CRF. John Deere will give the town \$29,000 for the trade in for the 1990 grader the town has now. Select Board Chair Norman Brown would like Mike to let the John Deere rep. that the town is very interested with the purchase of the 2017 grader and for him to set up a meeting so that they can discuss funding options and have all that info ready to go for the next meeting so that the Board can vote on the purchase. At this point because the trailer estimates that have been received are over the budgeted amount and the top priority is a new grader the Select Board could authorize the \$20,000 that was budgeted to be put towards the grader as well.
